This is a summary of the annual report of the Pike Electric, Inc. Group Benefit Plan, EIN 56-0587238, Plan No. 501, for the period July 1, 2009 through June 30, 2010. The annual report has been filed with the Employee Benefits Security Administration, U. S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Medical and dental benefits under the plan are provided through the general assets of the sponsor. Other benefits under the plan are provided through insurance.

**Insurance Information**

The plan has contracts with Standard Insurance Company, and Connecticut General Life Insurance Company, and Metropolitan Life Insurance Company to pay all Health, Short-term disability, Long-term disability, AD&D, and Life Insurance claims incurred under the terms of the plan. The total premiums paid for the plan year ended June 30, 2010 were \$694,726.
